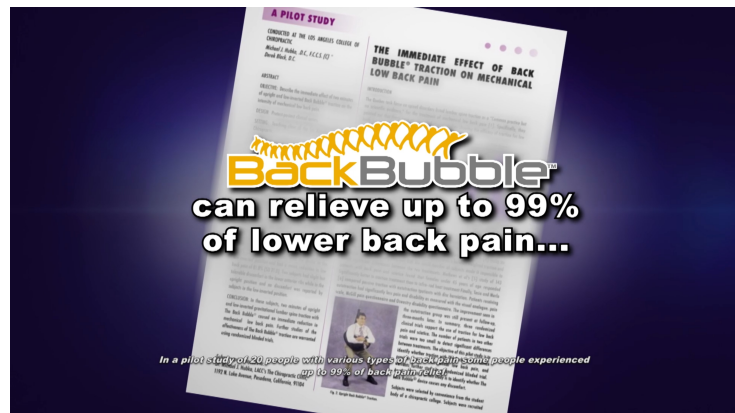

Dear Mr. Steele:

Mr. John Maley, Chairman of Chattanooga Corporation, has forwarded your letter requesting that we answer directly to you. He included *in* the letter an opinion that was written by an Erie physician based on the glossy flyer published by Chattanooga Corporation on its equipment, the Back Bubble-

We have found that this equipment, used for autotraction *or* gravity traction and for stretching, has its place *in* therapeutic treatment and rehabilitation of the back syndromes. We believe also that symptoms associated with osteoarthritis and degenerative intervertebral discs can be successfully treated with the modalities of traction and stretching.

We do not recommend, and do not expect any physician to recommend, such treatment for malign *disease* of the spine or low back.

The Medical Advisory Panel to Chattanooga Corporation rendered a favorable opinion on the Back Bubble as a method to apply traction and stretching. Subsequent to its production, this equipment has been demonstrated at national meetings, including the American Academy of Orthopedic Surgery. Thus, we believe the Back Bubble, when correctly used, has its place in physiotherapy and rehabilitative medicine.
